## RIGHT OF WAY (ROW) APPLICATION GUIDELINE

In accordance with the provisions of The Jos Metropolitan Development Board Edict 1974. Part II, section 8 Plateau state Revenue Consolidation Law 2020, Second schedule, Part B7

- **OBTAIN APPLICATION FORM** from: Jos Metropolitan Development Board, # 21 Ibrahim Dasuki Street, Jos City, +234 8033833057.
- **GATHER AND SUBMIT COPIES OF ALL REQUIRED DOCUMENTS. Originals are preferred.** You are advised to have photocopies made for safekeeping.
  - Photo ID of Directors of the company: National ID Card or International Passport or Driver's License or Voter's Card
  - Passport photographs of the Directors of the company
  - Certificate of Incorporation
  - Certified True Copy (CTC) of Articles & Memorandum of Association
  - Certified True Copy (CTC) of Form CO7 (List of Company Directors)
  - Tax Clearance Certificate or Evidence of Current Tax Clearance Certificate.
  - Certificates of qualified technical staff (where applicable)
  - Application Letter to include Proposed routes, Routes diagram, Distance to be covered, completion timeline.
  - A project proposal, including a list of routes, scope of work, budget, evidence of funding, portfolio of prior fiber deployment, site survey/assessment plan, risk assessment, occupational health and safety plan
  - Evidence of payment for application of N 145 / linear meter
- **COST AND LOCATION OF PAYMENT:** An application will be given an Invoice Number (generated from the system using state TIN) through which they can then proceed to any Bank to make payment of a one-time, non-refundable deposit of N 145/linear meter Prime Charge (Processing Fee). Other fees, such as charge for distance of fiber deployment, will also be charged at the Offer stage.
- **TIMFRAME:** Submitted applications will be processed within 10 working days, as long as they meet the minimum standards to be processed. All documents must be submitted to the Jos Metropolitan Development Board along with a Bank Teller/ Bank print-out for the prime charge or mailed to Jos Metropolitan Development Board, # 21 Ibrahim Dasuki Street, Jos City, Plateau State.
