# **1** Summary of Performance

# **1.A** Introduction

This Budget Performance Report for Plateau State is prepared quarterly and issued within 4 weeks from the end of each quarter.

This report includes the original approved budget and revised/final budget appropriation for the year 2023 against each organizational unit for each of the core economic classification of expenditures (Personnel, Overheads, Capital, and Others); the actual expenditures for the quarter Q2, attributed to each organizational unit, as well as the cumulative expenditures for year to date, and balances against each of the revenue and expenditure appropriations.

This Q2 report is assessed against the 2023 Original budget.

The core economic classifications refer to:

- Personnel Economic Sub-Account Type 21
- Overheads Economic Account Class 2202
- Capital Economic Sub-Account Type 2300
- Others Economic Account Classes 2203-2209 as applicable

This Budget Performance Report is produced by the Ministry of Planning and Budget/ Plateau State and published on the Plateau State website.

# **1.B** Revenue Performance

From the Budget overview Table 1, the Revenue from the Federal Government to the State is N22,723,445,556.30 presenting 28.5% of the Approved Government Share of FAAC (Statutory Revenue). While the Internally Generated Revenue (IGR) stands at N10,763,456,472.57 only representing 41.0% of the Approved Estimate.

The above Recurrent Revenue for the Q2 has a total performance of 31.6% showing the total collection of N33,486,902,028.87 only.

Donor Agencies also contributed N2,591,858,548.02 only in the Q2 performance as Aids and Grants to the State, representing 5.9%.

# **1.C** Recurrent Expenditure Performance

The consummated Personnel emolument for the Q2 performance is N7,733,063,753.53 only. This performance is very low because March-June Salaries are yet to be paid. And the total Overhead Cost Expenditure for the same period amounted to N6,404,705,368.86 representing 14.4% of the total Approved Recurrent Expenditure.

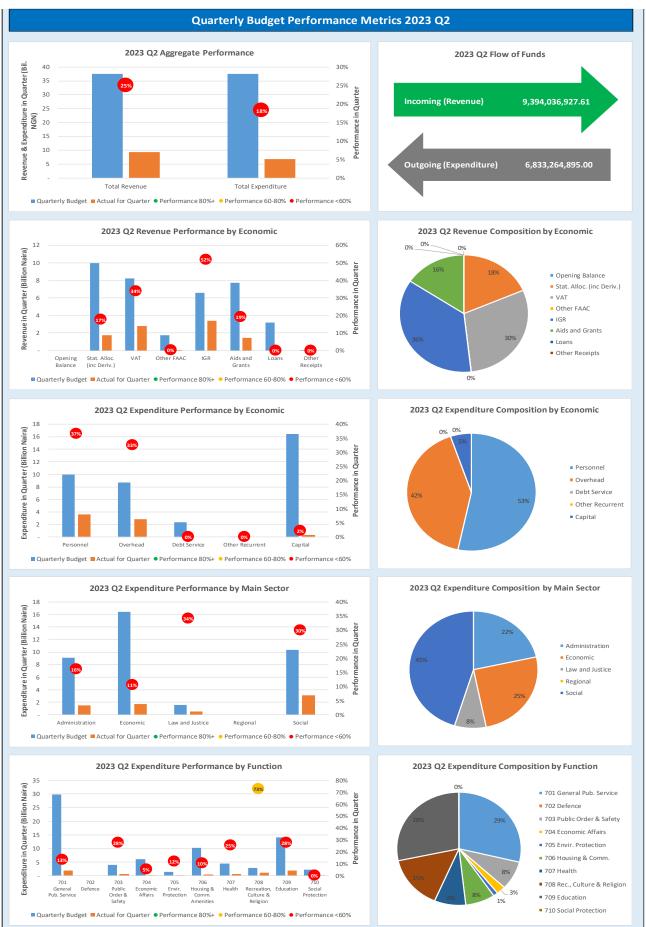
# **1.D** Capital Expenditure Performance

The total sum of N2,230,010,927.43 of the Approved Capital Expenditure was spend on projects across the State in Q2. This performance is very low because the administration is rounding up. Q3 will project real figures when returns fully compiled

# **1.E Conclusions**

In conclusion, there is a total collection of N36,078,760,576.89 representing 24.1% as Revenue in the Q2 and total Expenditure of N16,724,921,979.95 only representing 11.2%. The delayed returns figures leading to low performance will be added and explained in the next Quarter.
